ABOUT THE AUTHOR : - Isaac Asimov is a well known essayist of English literature. Isaac Asimov, a Russian born American author and bio-chemist has invented science fiction as new branch of literature in which he explains science concepts in a historical way.

SUMMARY : - As the author to this essay, in its two parts - the Pre - Scientific Universe of Science Fiction; is a bio-chemist and renowned for writing science fictions and science books, it is natural that he is here talking about science fiction with introduction on their origin, the events, human instincts and the name by which these science fictions were called during pre-historic period. He first starts with story as essence of writing on each and every mode, manner, intention etc. He tells magnificence of story, its origin through human beings gregarious interactions, collections, conversations, gossip etc.

The author says a story may involve - not the clash of baseball and bat, or of hockey stick and puck, but of gas-gum and sphere in an atmosphere enclosed on a space station under zero gravity. Fictions are written by taking

into consideration, the stages of development in the fields of science the technology at the current level and the author imagines the phenomenon; these subjects will do in future. 
### LONG ANSWER TYPE QUESTIONS :-
